The Board of Mayor and Aldermen of the City of Sparta, White County, Tennessee, met in a regular scheduled meeting at the City Hall, at 5:00 PM on the 5th day of July 2018, with Mayor Jeff Young presiding.

A quorum was present and notice had been previously mailed to all members and the news media. Mayor Young called the meeting to order. Police Chief Guth opened with a prayer by request of the Mayor. Alderman Robert Officer led the Pledge of Allegiance by request of the Mayor.

There was a motion by Alderman Payne with a second by Alderman Lowery to approve the minutes of the June 21, 2018 regular meeting, which had been previously mailed to all board members and read by each member prior to the meeting. All voted "Aye" by voice vote. Motion passed.

There was a motion by Vice-Mayor Floyd with a second by Alderman Payne to approve Ordinance No.18-916 on second and final reading, an ordinance to amend paragraphs 1-105, 1-112 and 1-113 to Title 1, Chapter 1 of the Sparta Municipal Code increasing the pay for the office of Mayor, Vice-Mayor, and Alderman of the City of Sparta, Tennessee. The low bids of Kemira PAX-XL 8/lb. at .26/lb. from Chem-Trade did not meet specs and the next low bid was Dycho at .339/lb. Chor-Chem and Brenntag will not deliver just one product, so they have declined the bid and the next lowest bid for Muriatic Acid was awarded to Dycho. The roll call was as follows:
