There was a motion by Alderman Jones with a second by Alderman Payne to approve Ordinance No.22-946 on first reading, an Ordinance to making and fixing the annual appropriations of the several departments of the City for the fiscal year, beginning July 1, 2022 and ending June 30, 2023.
